1) Finance Report

• Interim Business Manager, Nancy Swanson presented the Finance Report. Nancy also stated that she will present another budget amendment at the June Board meeting.

3) Superintendent's Report

- The Board received information on a gross settlement amount from the JUUL class action suit that will be paid over the next 3 fiscal years. Superintendent Doerr reported that in addition to these financial settlements, vaping companies are facing extreme restrictions on the sale of flavored vaping products. This will have a serious impact on the marketing toward minors going forward.
- Mr. Doerr shared that another class action suit is developing regarding the aggressive tactics
 of social media companies targeting minors. He will share more information about this action
 as it becomes available.
- On May 2, 2023, the East Jackson community will vote on 2 important ballot measures. First, the district is requesting a renewal of the Non-Homestead millage. Second, the JCISD is requesting a renewal of the special education millage. Both of these are important elections that have impacts on the district's operating budget. Neither election will increase the tax rate for any resident of the district.
